How To Be A TAAB Member



The Governing Body solely reserves the power to admit members & may refuse to admit any organization / person as a member without assigning any reason therefore.

- > *The membership of association shall be open to organizations associated with travel/tourism/hospitality sector for more than 1 year and of sound professional reputation and standing.*
- > *All applications of membership must be made on the prescribed form (may be downloaded from website) and must be proposed and seconded by one Governing Body members of the association.*
- > *The membership application shall be considered by the Executive Committee in a duly convened meeting and approved by a majority of two third of the members present.*

Membership Category

The membership of the association shall be composed of 1) **ALLIED MEMBER**, 2) **ACTIVE MEMBER** and 3) **ASSOCIATE MEMBER**. The Governing Body may at any time create different classes of members and may provide for entrance fees and subscription and define their respective rights and privileges. The Governing Body shall have power to dispense with payment of the entrance fee and membership fee, if they deem fit. The decision of the Governing Body will be final in all cases.

ALLIED MEMBER Any organization, which is regularly engaged / associated with tourism and travel industry such as carrier company, hotelier, restaurant, excursion agent, transport contractor, forwarding and clearing agent, shipping company, state tourist corporation or organization, hotel marketing representative / agency, trade publication and any overseas organization shall be eligible for membership as an ALLIED MEMBER who shall have the right to participate in the activities of the association except to vote.

ACTIVE MEMBER An organization, having established place of business in West Bengal & operating for a minimum period of two years shall be eligible for membership as an ACTIVE MEMBER of the association provided an application is made & accepted by the Executive Committee. However only one office of an organization shall be admitted as an Active Member of the association.

ASSOCIATE MEMBER Any other offices including the overseas offices of an Active or Allied Member shall be eligible as an ASSOCIATE Member of the association. They shall have no right to vote in the proceedings of the association.

Termination of Membership

A member may resign from association & upon acceptance of his/her resignation by Executive Committee, he/she shall cease to be member

The annual subscription of membership shall become due on 1st April of each year. If the subscription is not paid within 60 days from 1st April of each year, the member will be deemed to be defaulter. If any member fails to pay his subscription beyond the period of 60 days from 1st April of each year, the secretary may issue a notice calling for payment of such dues within 30 days and if payment is not made within this said 30 days from the date of receipt of the notice, the member shall cease to be a member of the Association.
